Registration Procedure & Payments

Tiny Tots is a program for children 3 & 4 years of age born in 2006 or 2007. Children who are turning 3 years of age before December 31, 2010 will be accepted, but only if "potty trained".

Registrations are accepted on a first come first served basis at the Recreation Services Office situated in the Vernon Recreation Centre. Registrations are ongoing until all classes are full. If registering online by Visa or MasterCard a follow-up visit to the Recreation Centre will be required to fill out the necessary paperwork.

Monthly fees are averaged out over the entire school term. A registration deposit is due at time of registration, and is not refundable (but will be applied to Tiny Tots June fee.)

At the time of registration, you will need to provide us with your Visa or MC # and expiry date (your card will be processed on the 1st day of each month.) or nine (9) postdated cheques, payable to City of Vernon and dated the 1st day of every month September 1, 2010 to May 1, 2011. Please note you will be charged an extra \$25.00 service charge for any cheques returned NSF by your bank.

We require a two week notice of withdrawal from the Tiny Tots program. Charges will be made according to when the notice is given. In case of the cancellation of a class a full refund will be provided.

Tiny Tot fees are tax deductible. Keep your receipts for tax purposes. If you lose your receipts and you require us to do a "receipt search", there is a \$15.00 administration charge.

Some parents may be able to receive subsidy for their child's participation in Tiny Tots. Parents can inquire at the Employment & Income Assistance Office located at 2600-48th Avenue or they can call 1-866-866-0800 and speak to a Child Care Subsidy worker.

Fun Family Phonics

Participants in our four year old classes will also experience the Fun Family Phonics a colourful and interactive program designed to help teach your child to read.

A pre-reading program suitable for pre-kindergarten to grade 1. Fun Family Phonics combines humorous stories about why letters make the sounds they do with colourful pictures to illustrate the stories.

Through completing the activities and stories in the Fun Family Phonics, your child will begin to recognize all upper-case and lower-case letters, begin to print all upper-case and lower-case letters using the proper writing strokes, know the sounds of all the letters independently and begin to sound out and read simple words.

Classes are offered one, two or three days a week.

At Tiny Tots you have your choice of attending classes one, two or three days per week, mornings or afternoons; whatever is right for your child and your schedule.
